## **ELECTRONIC FUNDS TRANSFER (EFT) BILLING RULES (email address required)**

## If you allow EFT, you understand and agree that BCBSOK and/or the company BCBSOK chooses to process payments may take monthly payments from your checking or savings account in accordance with the terms below:

- Future payments are due on the last day of the month before the month of coverage.
- Payment will be made as you choose on the previous page.
- Your bank or credit union will process these payments.
- If the payment date falls on a non-business day or a holiday, the payment will be taken on the next business day.
- Please make sure you have enough money in your account when you submit this Application. If a payment is denied for non-sufficient funds (NSF), BCBSOK may try to process the charge again at any time in the next 30 days. BCBSOK will not pay you back for any fees your bank or credit union charges you for not having enough money in your account.
- Both the bank or credit union and BCBSOK reserve the right to end this payment program or your participation in it if payment is denied for NSF. This means payments would not be made automatically anymore. Coverage may stop (claims would not be paid) if you do not pay your monthly bill.
- To change the bank or credit union these payments are paid from, you will need to give at least 10 days' notice to BCBSOK by telephone before a scheduled payment date.
